### Pooled Fund Approach to Liability Matching

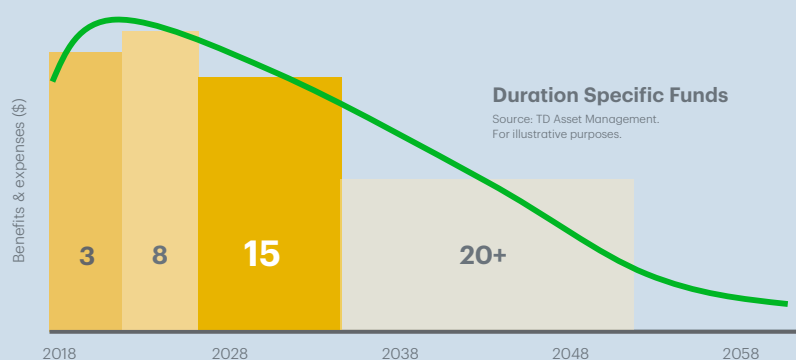


Figure 1: % Returns as at Sep 30, 2019	Q3-19	YTD	1 Yr	Annualized
